Enrollment Report Winter 2024*

ALL State FTES: Winter quarter enrollment **4,159** and currently **107**% of our state enrolled and budgeted target. Our Winter quarter state target is **3,893** FTES.


BAS: Winter quarter enrollment is **195** and currently at **135**% of our BAS enrolled and budgeted target. Our Winter quarter BAS *enrollment target is **145** FTES.

International: Winter quarter enrollment is 51 and currently at 127% of our International enrolled and budgeted target. Our Fall quarter International *enrollment target is 40 FTES.

Running Start: Fall quarter we have 1,506 Running Start students and currently at 109% of our RS enrolled and budgeted target. Our Fall quarter RS *enrollment target is 1,383 FTES






Total Financial Aid Disbursed



Number of Student Veterans by VA Support




Number of Athletes by Sport


Race/Ethnicity of Clark Students, Winter 2023*, 2024**


Gender of Clark Students, Winter 2023, 2024*





Age Group of Clark Students, Winter 2023*, 2024**




Student Type of Clark Students, Winter 2024*






Fall 2021, 2022, 2023
