
Eliminated programs:

This is in reply to your correspondence dated August 4, 2015, and received in our office on August 10, 2015, requesting approval from the Northwest Commission on Colleges and Universities (NWCCU) for Clark College to add an Associate in Applied Technology (AAT) degree program in Honda Initiative for Technician Education with Clark College (HiTECC) Automotive Technology and a Certificate of Proficiency program in HiTECC Automotive Technology to its education offerings, effective summer 2015. The AAT degree program in HiTECC Automotive Technology requires 110 credits to completion; the Certificate of Proficiency program in HiTECC Automotive Technology requires 104 credits to completion and both the degree and certificate program are related to existing offerings. Clark College has existing resources and capacity to offer the AAT degree program in HiTECC Automotive Technology and the Certificate of Proficiency program in HiTECC Automotive Technology.

Additionally, Clark College is requesting approval to rename the Associate in Applied Technology degree program in Automotive Technologies (109 cr) to Associate in Applied Technology degree program in General Automotive Service Technology (95 cr). Clark College is requesting approval to rename the Certificate of Proficiency program in Advanced Automotive Service (54 cr) to Certificate of Proficiency program in General Automotive Service Technician (61 cr). Clark College is requesting to eliminate the Certificate of Proficiency program in Basic Automotive Service (90 cr). The teach out plan for all students currently enrolled in the Certificate of Proficiency program in Basic Automotive Service is to transition each one into the Certificate of Proficiency program in General Service Automotive Technician.


