



# APPLICATION FOR NON-RESIDENT WAIVER

Clark College offers non-resident waivers to U.S. Citizens, Permanent Residents and Refugees who live in the State of Washington. *The non-resident waiver tuition rate is the equivalent of Washington resident tuition, plus a surcharge*

All applicants must provide at least **one** piece of evidence showing they reside in the State of Washington before the beginning of the term to be eligible for this waiver.

- Washington driver's license
- Rental or lease agreement
- Closing statement of a home purchase
- Voter's registration card
- Vehicle registration

**IMPORTANT:** Once you have established your Washington residency for at least 12 months, you may be eligible for a reclassification to in state tuition rates. This is not an automatic process. You will need to submit the Residency Reclassification application and required documentation for consideration. The application form is available in the Admissions office.
