Major Accomplishments:

- Championed the development of a comprehensive five-year strategic plan through intensive community and college engagement.
- Brought a comprehensive fiscal planning process to the College that included three-year scenario planning to assist the Board, College, students and the community understanding of decision implications for tuition, human resource, and service changes.
- Championed College's successful Northwest Commission on Colleges and Universities accreditation utilizing new standards. MHCC was in year 5 of its current accreditation and successfully completed the year 7 review.

- Championed successful negotiations of MHCC employee agreements to include full time faculty; part time faculty; and classified employees working with negotiation teams and the MHCC Board of Directors.
- Initiated comprehensive grants and resource development strategy resulting in increase of \$9 million in grants in under 3 years.
- Initiated and supported the institutional prioritization of social equity and cultural competence. This work include participation in the Oregon Campus Compact Executive Learning Series on Equity and Empowerment for 2 years; the recognition as a shared governance council the Access, Equity, and Diversity Council; Board adoption of a College Diversity Plan; and the hiring of the College's first Director of Access, Equity and Inclusion (reporting to the president's office). This work planted the seeds for a major cultural shift through education, training and experience.
- Initiated and supported environmental sustainability work of the College through participation in American College and University President's Climate Commitment; American Association of Community Colleges SEED initiative; Energy Trust of Oregon; and the City of Gresham/GREAT Business. MHCC recognized as a 2017 finalist for the annual Second Nature Climate Leadership Award; MHCC awarded \$1.2 million in capital resources for bio swales and sustainability projects; MHCC awarded Salmon Safe certification (first community college in the nation); regional winner of Northwest Earth Institutes sustainability challenges; and recent recognition by McKinstry as 2019 Champion of Sustainability.
- Championed the development of Mechatronics Program including the bringing together of \$1.2 million in start-up dollars – all funding was through state, local and industry support. Championed development of Subaru Factory Certified Training Program. Worked with local healthcare providers to bring Certified Medical Assistant Program back to MHCC.
- MHCC Foundation doubled its endowment including the College's first \$1 million gift through strong relationship development and re-establishing ties with key donors and friends.
- After the loss of the Teaching and Learning Center at MHCC, advocated for the re-invention of the TLC in support of quality teaching in collaboration with the fulltime faculty association.
- Lead efforts to address students' admissions and registration challenges by negotiating with the Educational Advisory Board to bring 'Navigate' to MHCC as a beta college for Jenzabar implementation.
