A. ASCC

Claudia Carrion gave an ASCC update. Ms. Carrion shared that the Penguin Pantry distributed 4,500 pounds of food in November. Ms. Carrion shared that training is underway for the new ASCC members.

B. WPEA

Angela Dawson gave an update on WPEA and highlighted ongoing concerns the WPEA have regarding Executive Cabinet's communication and lack of transparency. Ms. Dawson shared that the WPEA seeks to have productive dialogue regarding these concerns.

C. Foundation

CEO Gibert shared that the Foundation is grateful for all the work that is being done on the Boschma Farms project. CEO Gibert shared the Foundation Board approved the City of Ridgefield's right away request. CEO Gibert shared that the Foundation Board approved the Operating Agreement and shared that there will be supplemental materials provided to the Board of Trustees. CEO Gibert shared the Foundation has two new board members, Gabe Jacobsen and John Rose.

Vanessa Bural shared a PowerPoint Presentation regarding Talent Development. Ms. Bural highlighted Talent Development programs and trainings (Power, Privilege and Inequity, New Employee Orientation and Supervisor Training Series). Ms. Bural shared the Talent Development offerings (Higher Ed Works Training, Classified Staff Excellence Awards, Professional Development Funds Request, LinkedIn Learning Licenses, Employee Assistance Program, Employee Resources Group, Equity in Hiring, Supervisory Trainings, Teaching and Learning Days, Wellness Sessions and activities). The Trustees shared their appreciation for Ms. Bural's presentation.

President Edwards shared that there are over 5,000 students currently enrolled at Clark (60% are online, 20% hybrid and 20% face-to-face). President Edwards shared that Dr. Raymond Lee, from PeaceHealth, will be sharing information about COVID in an upcoming Zoom meeting for Clark employees. President Edwards congratulated Dr. Rashida Willard on her recent doctorate accomplishment and invited her to share about an upcoming conference she is organizing. Dr. Willard shared that she is developing workshops and presentation for the NW Regional Equity Conference, scheduled for February 2022, and anticipates it being well attended.

VI.Reports from Board Members

Trustee Strong shared that she has continued to have monthly meetings with President Edwards and shared her appreciation for President Edwards' leadership at Clark.

Trustee Canseco Juarez shared that he attended the remote Clark Winter Holiday Celebration and participated in an Association of Community Colleges Trustees Town Hall. Trustee Canseco Juarez updated the Board that he attended a briefing regarding an accountability audit and shared that the financial audit will begin next year. Trustee Canseco Juarez shared his appreciation for Clark Alumni and all the work they do in the community. Trustee Canseco Juarez congratulated Dr. Rashida Willard and her recent doctorate accomplishment.

Trustee Speer shared that he attended the Association of Community Colleges Trustees Town Hall. Clark College ASCC Board of Trustees Report

January 2022

Clark College Students Resource Access

The ASCC Student Government worked to ease students return to campus by providing awareness of college resources such as clubs, leadership opportunities, the tutoring center, workshops, events and scholarships. Some specific activities include:

- Working with the Penguin Pantry throughout the months of November and December, bringing the total number of students and family members served throughout this academic year to 1,693, including 533 food boxes, totaling 16,133 pounds of food.
- Sent Winter Quarter mailer to 4,728 students, updated to include new information, including technology support, Bookstore, campus services, leadership opportunities, free bus passes, a campus map, and Wi-Fi access.

Clark College Campus Climate

ASCC Student Government worked to reengage students on campus through the below activities:

- During Welcome Week, the ASCC setup greeting tables throughout the campus buildings to share college resources, snacks, gently used school supplies, as well as provide information and answer questions.
- Unfortunately, the planned Winter Quarter Involvement Fair was cancelled, due to rising cases of COVID-19 in Clark County. The event would have followed up on the successful Fall Quarter Involvement Fair, which saw roughly 100 students participate. The ASCC Student Government is working to find and create events online to compensate for the loss of physical interaction, and to continue to foster a sense of community among students, despite pandemic guidelines.
- An open forum with Dr. Karin Edwards and Dr. Michele Cruse was held virtually on January 12th as an opportunity to provide students with updates and answers to questions. Three students attended. Most questions centered around COVID-19 and some items like food and printing specific to evening students.

Clark College Statewide Initiatives

ASCC Student Government has continued partnerships with:

- The Washington Community and Technical Colleges Student Association (WACTCSA) through the Student Legislative Platform Development series.
- Communities for Our Colleges, working on a proposal for a bill to increase Washington College Grants.
- ASCC President, Executive Assistant and Finance Director participated in Clark College's Legislative Meet & Greet on Friday, January 7th. Student Involvement, COVID-19 closures & guidelines, and Running Start were main topics of discussion between ASCC and Legislators.

General Work Updates

- ASCC President Xander Hawkins and Student Relations and Promotions Coordinator
 Casey Figone are working on a Discord server for the Student Government, to improve
 outreach and accessibility for students.
- ASCC Student Government is nearly a complete team, missing only the Civics and Sustainability Director. The position is still open for applications. Elsewise, all other roles are filled adequately.
- Four clubs- the Japanese Club, the Environmental Action Club, ACES, and the International Club are active virtually, and the ASCC Government is considering methods of encouraging involvement with the Clubs among students.
