The work session reconvened at 4:03 p.m.

No action was taken by the Board during the Executive Session.

#### Spring Term Enrollment Profile

Dr. Cruse, Vice President of Student Affairs and Dr. Martin, Associate Vice President of Planning and Effectiveness, provided a comprehensive overview of the spring term enrollment. They noted a significant 11.6% increase in enrollment and highlighted a rise in the utilization of student services. Disability support reported 513 registered students with disabilities for spring 2024. Financial aid disbursed \$4,610,076 in grants, \$1,908,650 in direct loans, \$7,751 in scholarships, and \$319,893 in Work-Study (WES) for the quarter. Challenges discussed included issues faced with the revised FAFSA, and concerns regarding fraudulent accounts. Student demographics revealed a veteran population of over 200 students and 189 student-athletes enrolled. Community and Continuing Education reported 885 enrolled students, with enrollment increasing throughout the term.

#### 2025 Legislative Priorities

Dr. Edwards presented an overview of the proposed 2025 legislative priorities and timeline, highlighting a collaborative effort involving State Board staff, college presidents and chancellors to develop a survey aimed at identifying policies and budgetary needs. The Legislative Affairs Committee provided insights into key areas of focus for attention. It was noted that a second survey is currently underway for completion by the Board of Trustees (BOT) and Executive Committee (EC).

#### Early Tenure Vote

Trustee Gideon moved that the Board of Trustees, after having given reasonable consideration to the recommendations of the Tenure Review Committee, grant early tenure to Elizabeth Jochim. Trustee Bennett seconded the motion. Motion passed as presented.

#### **Constituent Reports**

The board highly values the constituent reports and again asked that written reports be submitted on the Friday before each board meeting.

#### ASCC

ASCC President Emma Sturm shared the following update:

ASCC Student Government distributed 154 Penguin Pantry boxes, hosted Welcome Week tables offering information and snacks, and held the last Involvement Fair of the academic year. Initiatives to reengage students included participation in a Phi Theta Kappa meeting, presentations in College 101 classes, and hosting the Suit Up for Leadership event. Additionally, the ASCC Student Government is forming partnerships statewide, such as with the Clark County League of Women's Voters for the Let Your Voice Be Heard event, while also preparing for the Oswald Awards.

#### Multicultural Peer Mentors

Mercy Kariuki, Multicultural Peer Mentor, provided an overview of the program's objectives, emphasizing the importance of inclusivity and diversity. She introduced the current year team, showcasing their roles and contributions. Reviewing core values centered around advocating for student equality and understanding power dynamics, she emphasized the program's commitment to supporting communities across campus. Highlighting three quarterly luncheon events as opportunities to bolster student success, Mercy underscored the program's dedication to supporting student groups like the Latinx Student Union, Black Student Union, and Queer Agenda. She also discussed the significant impact of the program's recent attendance at the Student of Color Conference state conference on participating students.

#### Reports from the Board Members

#### Trustee Scarbrough

Trustee Scarbrough acknowledged Community College Month and commended Maureen Chan-Hefflin for her exemplary communication efforts. Additionally, she attended Cohort 146 Nursing Pinning Ceremony, highlighting the vibrant atmosphere at the ceremony.

#### Vice Chair Gideon

Vice Chair Gideon participated in Trustee Tuesday, where Dr. Edwards delivered a presentation. She also had a one-on-one meeting with Dr. Edwards and attended a joint Board Chair and Vice Chair meeting with President Edwards.

#### Trustee Donaldson

Trustee Donaldson reported having no updates or items to share.

#### Trustee Bennett

Trustee Bennett praised Maureen Chan-Hefflin and her team for their excellent media coverage of the college. She also had her one-on-one meeting with Dr. Edwards. Trustee Bennett then addressed the public comments at the March 13, 2024, BOT meeting; concerns were raised regarding the hybrid meeting format's compliance with the Washington State Open Public Meeting Act. Referencing a 2017 attorney general opinion, which allowed meetings via telephone conference with proper notice and public access, Trustee Bennett highlighted that our current format, allowing public attendance and comment both virtually and in person, aligns with the act's requirements. Trustee Bennett expressed appreciation for public input and welcomed the opportunity to clarify the board's practices.

#### Chair Canseco Juarez

Chair Canseco Juarez expressed gratitude to all meeting attendees, with a special acknowledgment to the Board members. The diverse expertise, experience, and personal qualities of Board members were emphasized, reflecting their commitment to effective leadership. The collaborative support for the college's mission, enriched by the diversity of the Board, was warmly appreciated for their valuable contributions. Additionally, he noted that they adhere to federal, state, and college requirements as a governance board. Chair Canseco Juarez reviewed the Board's responsibilities, such as conducting tenure candidate interviews, employing a chief executive officer as an institutional leader, and overseeing fiscal matters. Furthermore, Chair Canseco Juarez underscored the importance of supporting President Edwards's work to advance the institution's mission and ensure effective day-to-day management and overall progress of the college.

He shared the PenguinsGive opportunity with the Trustees and commended Maureen Chan-Hefflin and her team for their excellent media coverage of the college.

#### President's Report

Dr. Edwards echoed Chair Canseco Juarez's sentiment about the trustees' service to the college and the community.

Dr. Edwards gave the floor to Calen Oullette, CEO of the Clark College Foundation, for an update on Penguins Give. Calen Oullette provided an update on Penguins Give, highlighting the impressive pre-day \$22,000 already raised.

Following this, Dr. Edwards discussed the successful CTE showcase, which brought 350 students from 21 high schools to campus. She discussed the upcoming Sakura Festival and Take Your Child to Work Day, which is scheduled for April 25. Dr. Edwards also discussed the recent budget presentations, emphasizing the opportunity to listen to the college's needs and explore innovative approaches or potential partnerships for requests that may not be funded. Dr. Edwards then gave the floor to Dr. Cruse, who addressed the challenges with FAFSA processing and fraudulent student accounts.

Calen discussed the student success fund, which aims to address financial gaps and enhance emergency grants.

#### **Clark College Students Resources Access**

The ASCC Student Government is working to ease students return to campus by providing awareness of college resources such as clubs, programs, workshops, events, leadership opportunities, the DEI office, and the tutoring center. Some ways that ASCC Student Government is working on doing this:

- Successfully handed out 187 Penguin Pantry boxes to students this past month.
- Began recruitment process for next year's ASCC Team. Posted information about the application process and what it means to be a student leader across campus. We have tabled at a few different events for recruitment.
- The Student Life Instagram account, which shares events happening across the campus among various programs and clubs, has increased its following amount to 1,032.
- Budget Requests: This past month ASCC approved the following budget requests:
  - \$130,065 for the reupholster of the furniture in the PUB building.
  - \$10,000 for the Women's softball team to have a new Scoreboard.

#### **Clark College Campus Climate**

ASCC Student Government is working to reengage students on campus. Some of the initiatives ASCC Student Government has done to achieve this:

- Hosted the Let Your Voice Be Heard Event in Hanna Hall on May 9<sup>th</sup>. This event allows students to write an anonymous note about any questions/concerns/kudos they have for Student Government or Clark College. We had over 73 students participate in this event.
- ASCC sent out a faculty survey on May 8<sup>th</sup> to ask faculty about their preferences toward either an annual and/or quarterly student award event ceremony. Completing this survey will help inform us what to do regarding recognizing students.

#### **Clark College State-Wide Initiatives**

ASCC Student Government have started to outreach to form different partnerships state-wide. ASCC Student Government has been able to accomplish this through:

• The Women League of Voters tabled at the Let Your Voice Be Heard event and were there to engage with students. They also partnered with the Civics and Sustainability Director to create a political survey for students to fill out. This survey primarily asked students about their knowledge about voting, civics on campus, etc. Approximately 40 students completed this survey.
