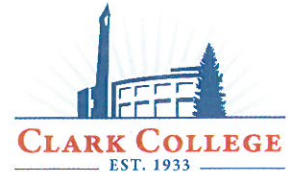


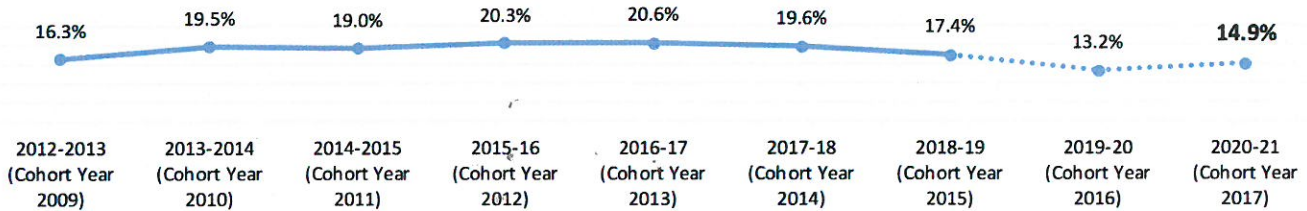

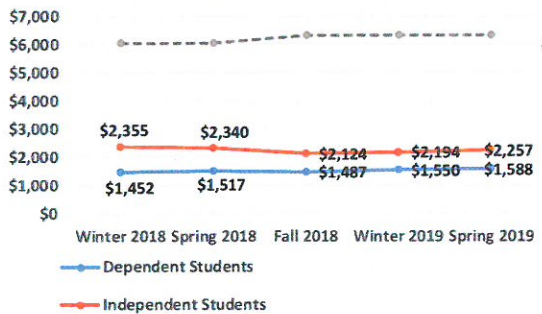

Student Three Year Loan Default Rate

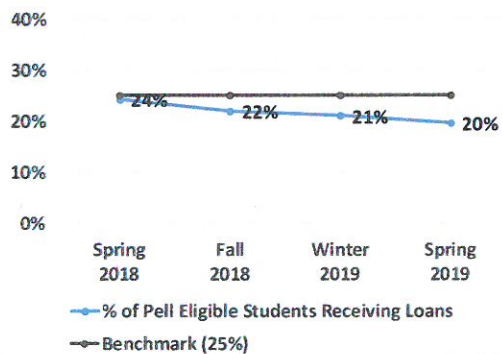


Average Loans Awarded and Received by Students, by Independent/Dependent Status
