COLLEGE UPDATES

INDUSTRY FEEDBACK

Kristi inquired about scanning for impression versus occlusal guards. She also asked about incorporating Cone Beam CT scanners into the curriculum.

Kendra noticed an increase in offices using cone beam machines. However, indicated that most times it was being taken by assistants and not the hygienist. She went on to say that digital impressions are also in use as well, and lasers are becoming more popular.

Steven noted he uses digital impressions for occlusal guards to be made.

Kramer recommended digital impressions.

Mike Ludwig said a scanning device would be helpful but also stated he does not want to abandon the traditional way as he is the one who covers this in the curriculum.

Pete recommends getting a scanner.

The meeting adjourned at 7:15 PM.
