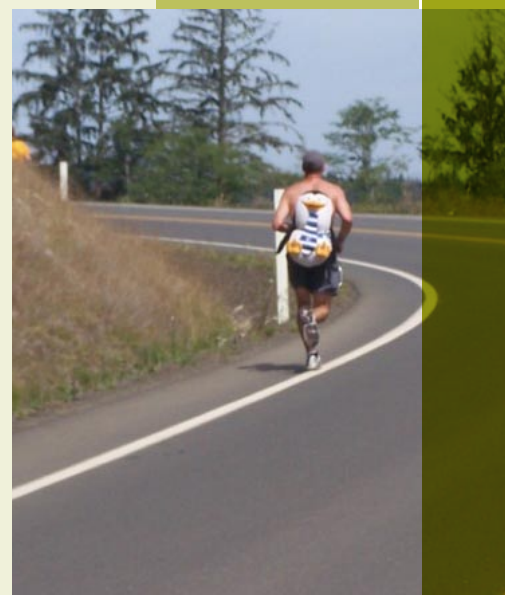

## EMBRACING HISTORY TO MAKE HISTORY: CLARK WELCOMES LEADERS OF THE NATIONAL PLUS 50 INITIATIVE

A visit to Fort Vancouver may result in second careers for baby boomers in South Dakota. On Tuesday, August 26, Clark College welcomed leaders of the American Association of Community Colleges (AACC) and Western Dakota Technical Institute (WDTI) as part of the national Plus 50 Initiative, which was created to support baby boomers as they take the next step toward their lives beyond traditional retirement age.

National statistics indicate that 10 thousand baby boomers are turning 62 years old every day in 2008. If all of them were to leave the workforce, the baby boomers could send the already struggling U.S. economy into the throes of a severe labor shortage. The U.S. Department of Labor projects that the country will be short 10 million skilled workers by 2011.

Nationally, Clark College has been designated as one of just five mentor colleges in the new program. As a mentor college, Clark will support efforts by WDTI, located in Rapid City, S.D., to develop and pilot a national training model for baby boomers who want to become seasonal rangers and interpretive guides at national parks.

To support that goal, the college invited Kim Morey, Director of WDTI's Plus 50 Initiative, to visit Fort Vancouver and the Vancouver Historic Reserve. Morey was accompanied by AACC representatives Mary Sue Vickers and Katya Nekrasova who serve, respectively, as executive director and program associate for the national Plus 50 Initiative.

Clark College President Bob Knight served as host for the visit. Knight's last duty in the U.S. Army was serving as Commander of the Vancouver Barracks. Elson Strahan, President and CEO of the Vancouver Historic Reserve, and Tracy Fortmann, Fort Vancouver Park Superintendent, accompanied the group. WDTI's Kim Morey is a retired Air Force captain.

Tracy Reilly-Kelly, Plus 50 Initiative Director at Clark College, notes that

"Rapid City is home to Ellsworth Air Force Base and many ex-military retirees. In addition, the areas hosts scenic wonders including Mount Rushmore, the Crazy Horse monument, the Badlands and the Black Hills. Western Dakota Technical Institute is creating a training program for the National Park Service to attract seasoned, seasonal workers for the diverse park programs and concessions – people age 50 and above who looking for the kind of part-time second career that will be the hallmark of the plus-50 Baby Boomer generation in years to come."

In all, the AACC and WDTI visitors spent three days at Clark College with a focus on the college's proposed programs for the next three years. As a mentor college, Clark College will redesign its small business development curriculum to offer second careers through business ownership at a wine and cooking school for wine hobbyists and food enthusiasts. In addition, the college will partner with the Southwest Washington Agency on Aging to train in-home caregivers.

**FOR THE THIRD CONSECUTIVE YEAR, GRADUATES OF CLARK COLLEGE'S FITNESS TRAINER PROGRAM HAVE EARNED A 100% PASS RATE ON THEIR NATIONAL EXAM.**

Three graduating classes. Three years of a 100% pass rate. Clark College's fitness trainer program has just marked that impressive accomplishment.

The nine members of the graduating class of 2008 had a 100% pass rate on the National Strength and Conditioning Association Certified Personal Trainer exam (NSCA-CPT). The exam is accredited by National Commission for Certifying Agencies (NCCA). Internationally, the current pass rate on the exam is 56.19%.

Fitness Trainer Program Coordinator Lisa Borho noted that, in addition to their 100% pass rate, Clark students made significant improvements in each area of the exam. Borho added, "It is rewarding to know that our efforts to enhance our curriculum and course offerings have paid off for our students."

Clark's fitness trainer program features master's degree level exercise science and physical education instructors, as well as those who are certified as Certified Strength & Conditioning Specialists (CSCS) credentials from the National Strength and Conditioning Association. According to Borho, the program goals are "to provide personal training by qualified, ethical and professional fitness trainers; provide employers with well-qualified, ethical and professional fitness trainers; and support national health goals by providing our community with graduates who are trained to empower clients to practice lifelong positive health behaviors."

One student recently wrote to an instructor: "I was impressed by the overall quality of classes and how well-developed lesson plans were—especially since the program is so new."

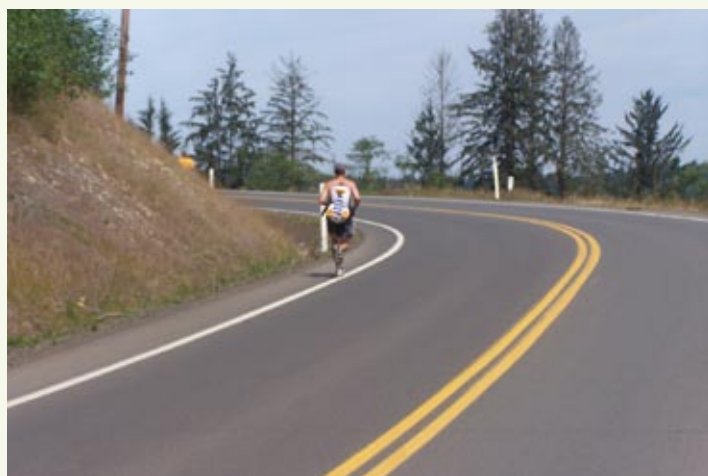

## SERVICE LEARNING FELLOWS

This fall, five members of the Clark College faculty will begin a year-long development program that provides participants the opportunity to investigate, develop, implement, and integrate service-learning into their teaching, research, and public service work while becoming recognized college leaders in service-learning pedagogy and community engagement.

Called Service-Learning Fellows, the program is supported by Clark's Service-Learning Program. Along with financial support, the fellows program includes professional development training and opportunities to present work to peers at Clark College and at the Washington Campus Compact annual conference in April 2009.

This year's Service-Learning Fellows, who will serve from September 2008-June 2009, are:



Deena Bisig, communications studies instructor, has worked closely with the Service Learning department at Clark, engaging more than 500 students in service learning. In addition, Deena is the Phi Theta Kappa advisor at Clark and incorporates

service learning within the honor society activities. Deena's idea is to create a leadership course that combines this curriculum with a service learning foundation. Students from all disciplines would be encouraged to enroll and would need to demonstrate college-level reading and writing skills.



Kathy Chatfield, senior instructional designer of eLearning and BTEC adjunct faculty, is one of just three dedicated instructional designers in Washington's 34 community and technical colleges. Since 1997, she has taught more than 100 technology-enhanced

community college and university credit-level courses in business and instructional technology, most of which she developed. Kathy is developing a service-learning component in her Computer Business Applications course and plans to offer the alternative of a service-learning project that relates to the use of Word, Excel, PowerPoint, and/or Access in some way.

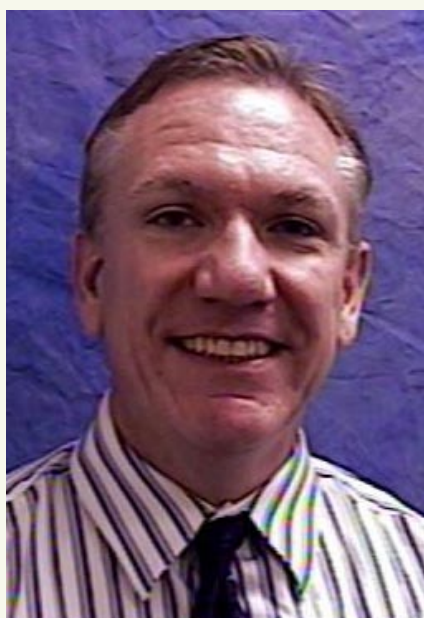

Layne Russell, director of the paralegal program and paralegal instructor, has worked in several non-profit organizations in which he has directed learning projects, mentored student interns, trained community volunteers, developed programs

around student fellows and more. Layne received the 2002 Fulbright Scholar Award at the University of Maribor in Slovenia where he lectured on the U.S. Legal System and U.S. and International Law. Layne will partner with the Court Appointed Special Advocates Program (CASA); an organization within the YWCA of Clark County, a nonprofit organization.



Suzanne Southerland, communication studies instructor, currently serves as the co-director of the Service and Leadership in the Community program. She uses service learning in her small group communication course and plans

to incorporate service learning into her cross-cultural communication course. Suzanne believes service learning creates community in the classroom, reaches students with varying learning styles, and enhances life-long learning—and it's just a lot of fun!

The goals of the Service-Learning Fellows program include:

- increasing familiarity and exposure to service-learning theory;
- developing service-learning components to academic courses;
- exploring assessment strategies for measuring the impact of service learning; and
- sharing ideas with colleagues and supporting faculty research on service learning.

Application to the Service-Learning Fellows program is open to all faculty members—including academic tenure track, adjunct, full-time temporary and tenured faculty members—with an interest in service-learning. Previous experience in service-learning pedagogy or familiarity with service-learning or civic engagement research is not required. Applications for the 2009-2010 program will be available in spring 2009.

## FROM THE HR DEPARTMENT



### RETIREMENT/RESIGNATION EARLY NOTIFICATION STIPEND

To ensure sufficient time for an effective search for a replacement, the college will provide a one-time stipend to faculty in probationary or tenured positions who provide notification to the college by October 1 prior to the calendar year of retirement or resignation. Probationary or tenured faculty who have at least ten (10) years of service, including temporary, special programs, probationary and tenured faculty appointments, as of their last date of employment, will receive a \$5,000 stipend; probationary or tenured faculty with less than ten (10) years of service as of their last date of employment will receive a \$3,000 stipend.

To qualify for this payment, the president must receive signed, written notification from the faculty member, including the last date of employment.

### VOLUNTEER REGISTRATION - REMINDER

College Administrative Procedure 430.005 requires all volunteers to register in advance with Human Resources, and to submit time sheets to Payroll at the end of each month in which volunteer services are provided.

Volunteer authorization forms are valid for one fiscal year at a time. Volunteers need to register with Human Resources before performing volunteer services.

### FACULTY/STAFF ADDRESS CHANGES

If you change your name, address or telephone number, please complete a name/address change form in Human Resources. Human Resources will forward changes to the Health Care Authority, however, you must notify your medical-dental insurance carriers.

### OVERTIME REGULATIONS

Under the provisions of the Fair Labor Standards Act, employers are required to compensate employees who are eligible for overtime for all work they are directed or permitted to perform, including hours worked beyond scheduled work hours; further, liability for compensation is incurred whether the employer knew or should have known that the employee was working.

College employees who are eligible for overtime compensation may not work beyond their regularly scheduled hours unless directed to do so by their supervisors. Supervisors, in turn, are responsible for insuring that employees do not work beyond scheduled hours unless specifically directed to do so. Simply put, employees who are eligible for overtime may not work beyond their scheduled hours, even on a voluntary basis, without receiving overtime pay or compensatory time off, at the employee's option.
